Sub:- Preparation of Waiting List for allotment of Govt. residences at Forest Research Institute Estate, New Forest, Dehradun, for the year 2012.

Waiting lists for allotment of various types of residences under FRI Estate for the year 2012 are required to be drawn up for which the priority for particulars type of residences of Type IV and above would be determined by the earlier date from which the applicant officer/official is continuously drawn grade pay indicated below, in the eligible office. In respect of Type-I, II and III the priority date shall be the date from which the applicant official has been continuously in service in the eligible office. The type of accommodation to which the official would be entitled and determined by the grade pay as defined under Fundamental Rules and relevant Indian Council of Forestry Research & Education, orders thereon drawn by the official as on 01.01.2012:-

The officials who are not in occupation of residential accommodation of the FRI Estate but are desirous of the same, are required to apply afresh for allotment failing which their names would not be indicated in the Waiting List.

The officials who are already in Govt. accommodation and have become eligible for higher type of accommodation by virtue of their grade pay as on 01.01.2012 may apply for the same failing which their names would not be reflected in the Waiting List.

All Head of Divisions, Offices/Sections etc. are requested to bring the contents of this communication to the knowledge of all the officials working under them and ensure that fresh applications for allotment of accommodation with grade pay for the purpose duly verified by the concerned DDOs are sent to the Building Section latest by 13.12.2011. Applications received after 13.12.2011 will not be entertained.
