The Director, Forest Research Institute, Dehradun requires to engage 01 (One) Allopathic Doctor (General Physician) on contractual basis at New Forest Hospital, FRI, Dehra Dun. Applications are invited from the desirous Doctors.

Essential Qualifications :

1. MBBS degree from a recognized Institution with permanent registration certificate from Medical Council of India/States.
2. The candidates should not be more than 50 year of age.
3. Preference will be given to the candidates having experience in working as General Physician in any Govt./Semi Govt. Hospital.
4. Selected doctor with qualification M.B.B.S. or equivalent will get an remuneration of ₹.54,000/- per month only plus ₹ 2,400/- as local conveyance p.m. and Selected doctor with qualification M.B.B.S. with M.D./Post Graduate degree or PG Diploma with minimum Two year experience in Govt. Hospital/Dispensaries service will get an remuneration of ₹.65,000/- per month only plus ₹ 3,000/- as local conveyance p.m (Consolidated).
5. The contract will normally be for a period of one year and **it will not confer any rights on the doctor for regular appointment.** On mutual consent between the Doctor and the Director, FRI, contractual period can be further extended. The Director, Forest Research Institute, Dehradun reserves the right to terminate the contract before expiry of the terms giving of one month notice to the doctor.
6. The Director, FRI reserves right not to fill the advertised post without assigning any reason
7. The duty hours will be similar to other medical officer on deputation at New Forest Hospital. He/she will be entitled to avail two days leave per month only. In case of not aviling leave no leave encashment will be paid.
8. He/she will be provided a rent free residential accommodation in the New Forest Campus.
9. In the event of the Doctor desiring ther earlier termination of the contract. he/she shall have to give at least two months advance notice to the Director, FRI.
10. No TA/DA etc. will be paid from this Institute to the candidates for attending the interview.
