1. Contractors who fulfill the following requirements shall be eligible to apply. Joint ventures are not accepted.

&

Contractor should have satisfactorily completed the works as mentioned below during the last **FIVE** years ending previous day of last date of submission of bid.

Three similar works each are costing not less than **Rs 21.00 Lakhs** OR two similar works each costing not less than **Rs. 32.50 Lakhs** OR one similar work costing not less than **Rs. 43.00 Lakhs**.

2. Similar work would mean “ **Road work by hot mix plant with paver finisher machine**” The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of receipt of applications for bids. (scanned copies of work experience certificates meeting to this criteria shall be uploaded by the agency).



3. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
4. Information and Instructions for bidders posted on website shall form of bid document.
5. The enlistment of the contractors should be valid on the last date of submission of bids. In case the last date of opening of bid is extended, the enlistment of contractor should be valid on the original date of opening of tender.
6. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.eprocure.gov.in free of cost.
7. But the bid can only be submitted after **deposition of original EMD in the Office of Head, Engineering & Services Division, FRI Dehradun within the period of bid submission. (The EMD document shall only be payable at Dehradun)** and uploading the mandatory scanned documents such as Demand Draft or Pay order or Banker's Cheque or Deposit at call Receipt or Fixed Deposit Receipt and Bank Guarantee of any Scheduled Bank towards EMD in favour of Director FRI Dehradun **as mentioned in NIT, receipt for deposition of original EMD to office of the Head Engineering & Ser. Division, FRI Dehradun** and other documents as specified.
8. **Tender fee: Rs.570/- (including 13.5% Uttarakhand Trade Tax) by crossed Demand Draft in favour of Director, FRI payable at Dehradun**, as tender fee/processing charges is applicable. The scanned copy of the same should be uploaded in the Web Portal during online submission is essential. The original draft of tender fee along with other tender documents should be submitted in the Office of Head, Engineering & Services Division, FRI Dehradun within the period of bid submission. .

The bidder who has already submitted tender fee and EMD need not to submit it again physically. They may uploaded the scanned copy of the same.

9. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.

The intending bidder must have valid **class-III digital signature** to submit the bid.

10. **The contractor can deposit original EMD in the office of the Head Engineering & Ser. Division, FRI Dehradun within the period of bid submission. (The EMD document shall only be payable at Dehradun). The contractor shall obtain the receipt of EMD from the Head, Engineering & Services Division FRI in the prescribed format uploaded by NIT issuing office.** The Bid Document as uploaded can be viewed and downloaded free of cost by anyone including intending bidder. But the bid can only be submitted after uploading and mandatory scanned



documents such as Demand Draft/Pay Order or Banker's Cheque of any scheduled Bank towards EMD in favour of respective Director, FRI Dehradun, **copy of receipt of original EMD** and other documents specified in the press notice.

11. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
12. Contractor can upload documents in the form of JPG format and PDF format.
13. Contractor must ensure to quote rate of each item.
14. In addition to this, if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).

However, if a tenderer quotes nil rates against each item in item rate tender on the lowest amount of the tender or any section/sub head in item rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer.

15. The required documents meeting the criteria to qualify as "approved and eligible contractors" for the following work along with other documents as mentioned under para "List of Documents to be scanned and uploaded within the period of bid submission", as uploaded by the agency shall be checked first, while opening the bid. The financial bid of only those agencies shall be opened who are found to be eligible agencies, as per this NIT.
16. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
17. If the agency is not registered with Uttarakhand VAT department earlier, he has to get register himself with Uttarakhand VAT department before submission of the bid.
18. **List of Documents to be scanned and uploaded within the period of bid submission:**
 - (a) Demand draft of tender fee.
 - (b) Demand draft/ Pay order or Banker's Cheque/ Deposit at call receipt/FDR of any Scheduled Bank against EMD.
 - (c) Enlistment Order of the Contractor.
 - (d) Copy of receipt for deposition of original EMD issued from office of Head, Engineering & Services Division, FRI (The EMD document shall be issued from Dehradun).

19. Following procedure shall be adapted to Deposit earnest EMD.

- (i) The Head, Engineering & Services Division should be received the original EMD for tender.

- (iii) **The Head, Engineering & Services Division receiving EMD and Tender fee in original form shall examine the EMD and Tender fee deposited by the bidder and shall issue a receipt of deposition of earnest money and tender fee to the agency in a given format uploaded by tender. The receipt may be issued by the Office of Head, Engineering & Services Division, FRI.**
- (iv) **The Head, Engineering & Services Division, FRI Dehradun receiving original EMD and Tender fee shall also intimate tender inviting Head, Engineering & Services Division about deposition of EMD and Tender fee by the agency by email/ fax/telephonically.**
- (v) **The original EMD receiving by the office Head, Engineering & Services Division, FRI Dehradun shall release the EMD after verification from the e-tendering portal website (www.tenderwizard.com> tender free view> advance search> awarded tenders) that the particular contractor is not L-1 tenderer and work is awarded.**
- (vi) **The tender inviting Head, Engineering & Services Division, FRI Dehradun will call for original EMD of the L-1 tenderer from EMD receiving office immediately.**

The following conditions which already form part of the tender document are specially brought to the notice of all intending tenderers for compliance while filling the tender.

They are requested to comply following instructions:

- After submission of the bid the contractor can re-submit revised bid any number of times but before last time and date of submission of bid as notified.
- While submitting the revised bid, contractor can revise the rate of one or more item(s) any number of times (he need not re-enter rate of all the items) but before last time and date of submission of bid as notified.
- When tenders are invited in three bid system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the tender submitted earlier shall become invalid.
- In case of composite tenders, the contractor submitting the tender should read all the three Parts of the tender viz. Part-A, B & C, which are containing schedule of quantities, additional & special conditions, additional specifications, particular specification and other terms and conditions given in the NIT and drawings for Major as well as Minor component of work. Details of these parts are summarized as under :



- **Part A:** - CPWD -6, CPWD – 7/8 including schedule A to F for major component of the work, Standard General Conditions of Contract for CPWD 2014 as amended/ modified up to last date of submission of bid.
- **Part B:** - General/specific conditions, specifications and schedule of quantities applicable to major component of the work.
- **Part C :-** Schedule A to F for minor component of the work, (Officer- in- charge of major component shall also be competent authority under clause 2 and clause 5 as mentioned in schedule A to F for major components) General/specific conditions, specifications and schedule of quantities applicable to minor component(s) of the work.

The **Major** Component of work is **Civil** Work and **Minor** Component of work is **Electrical** Work-

- The bidders should also read the General Conditions of Contract for CPWD from 7 as modified and corrected up to last date of submission of bid of this work, which is available as Govt. of India Publications; however provisions included in the tender document shall prevail over the provisions contained in this standard form. The set of drawings and NIT shall be available with the Head, Engineering & Services Division.
- The contractor should also visit the site of work and acquaint himself with the site and soil conditions before tendering.
- The main contractor shall execute the minor component(s) also. He should be either an eligible contractor himself or associate with himself an eligible agency(s) for execution of electrical work as per CPWD-6 for e-tendering. The contractor shall indicate the names of up-to three such agencies within prescribed time as “Minor component agencies”. In case the details of electrical agency are not submitted by the bidder or are not proper then these shall be submitted before acceptance of the bid.
- After acceptance of the tender by competent authority, the Officer- in- charge of major component of the work shall issue letter of award on behalf of the Director, FRI Dehradun. After the work is awarded, the main contractor will have to enter



into one agreement with Officer- in- charge of major component and has also to sign two/or more copies of agreement depending upon number of Officer- in- charge of minor components. One such signed set of agreement shall be handed over to Officer- in- charge of minor component. Officer- in- charge of major component will operate part A and part B of the agreement. Officer- in- charge of minor component(s) shall operate Part C along with Part A of the agreement.

- The main contractor has to enter into agreement with the contractor(s) associated by him for execution of minor component(s). Copy of such agreement shall be submitted to Officer- in- charge of minor component as well as to Officer- in- charge of major component. In case of change of associate contractor, the main contractor has to enter into agreement with the new contractor associated by him.
- Tenders with any condition including that of conditional rebates in the tender document shall be rejected forthwith.
- The rate (s) must be quoted in decimal coinage. Amount must be calculated and rounded in full rupees by ignoring fifty paisa and considering more than fifty paisa as rupee one. Rate must be filled both in words and figures. Amount should be worked out for all the items. Rates in words should start with word “Rs.” And finish with word “only” and there should not be undue gap in the words of the rate. For example, the rate of Rs. 2429.50 in figure should be written as “Rs. Two thousand four hundred twenty nine and paisa fifty only”
- The contractor shall have to execute guarantee bonds in respect of water supply and sanitary installation works and water proofing works as per Performa at Annexure I & II.
- Sales tax/VAT, purchase tax, turn over tax, Excise duty, work contract tax or any other tax on materials as applicable shall be paid by the contractor himself. The contractor shall quote his rates considering all such taxes. However, service tax shall be separately reimbursable to the Agency as per Circular No. DGW/CON/241 dated 28/01/2009.
- Attention is also drawn to Clauses 6, 6A and 7 of General Condition of Contract for CPWD works 2014, which prescribes the procedure for computerized recording of measurement and preparation of bill by contractor.



- Intending tenderer may submit physical mile stone on the basis of their resources and methodology at the time of tendering as indicated in the “Schedule F”, otherwise it will be assumed that agency is agreeable to physical mile stones mentioned in the table.
- Intending tenderer may give detailed activities/programme for each mile stone fixed in the tender document while submitting the tender.
- Recovery rates for less use of materials beyond permissible limits is given in Schedule ‘F’ of Part-A & C & also for excess use of departmentally issued material.

INSTRUCTION FOR E-TENDERING

Online item rate bids are invited on behalf of Director, FRI Dehradun from approved and eligible contractors of CPWD, MES, Railways, P & T, State PWD & other Govt. Department etc. for the following work of **Repair /repainting with semi dense bituminous Concrete surfacing (by Hot mix plant with paver finisher machine) of Lace road, Lauri Road, Hari Singh Road, Wilmot Road and KG campus road at FRI Dehradun**

1. The enlistment of the contractors should be valid on the last date of submission of bids.

In case the last date of opening of bid is extended, the enlistment of contractor should be valid on the original date of opening of bids.

The work is estimated to cost **Rs. 54,17,200/-**

This estimate, however, is given merely as a rough guide.

The authority competent to approve NIT for the combined cost and belonging to the major discipline will consolidate NITs for calling the bids. He will also nominate Division, which will deal with all matters relating to the invitation of bids.

1.1 For composite tender, besides indicating the combined estimated cost put to tender, should clearly indicates the estimated cost of each component separately. The eligibility of tenderer will correspond to the combined estimated cost of different components put to tender.

1.2 Conditions for all contractors

*1.2.1 The Contractor should have satisfactorily completed three similar works each of value not less than **Rs.21 Lakhs** OR two similar work each of value not less than **Rs.32.50 Lakhs** OR one similar work of value not less than **Rs.43 Lakhs** in last 5 years previous day of last date of submission of bid .*

Similar works mean “Road work by hot mix plant with paver finisher machine”.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the *previous day of last date of submission of bid*.

1.2.2 To become eligible for issue of bid, the bidders shall have to furnish an affidavit as under:-

“I/We undertake and confirm that eligible similar works(s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred for bidding in FRI in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Officer-in- Charge shall be free to



forfeit the entire amount of Earnest Money Deposit”. **(Scanned copy to be uploaded at the time of submission of online bid).**

- 1.2.3 It is mandatory for all contractors to upload the work experience certificate(s) and the affidavit as per the provisions of clause 1.2.1 and 1.2.2.

Online bid documents submitted by intending bidders shall be opened only of those bidders, whose “Earnest Money Deposit, Cost of Bid Document and e-tender Processing Fee” and “other documents including eligibility documents as required as per this NIT” placed in separate **sealed envelopes** marked as “Earnest Money, Cost of Bid Document and Cost of Bid Processing Fee” and “Other documents”, respectively are found in order. Both these envelopes shall be submitted together in another sealed envelope.

The financial bid of only those agencies shall be opened who are found to be eligible agencies, as per this NIT.

2. Agreement shall be drawn with the successful bidder on prescribed Standard Form which is available in office of Engineering & Services Division. Bidder shall quote his rates as per various terms and conditions of the said form which will form part of the agreement.
3. The time allowed for carrying out the work will be **30 days** from the date of start as defined in schedule ‘F’ or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the bid documents.
4. The site for the work is available.
5. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents except Standard General Conditions of Contract Form can be seen from website www.eprocure.gov.in free of cost and <http://fri.icfre.gov.in/>
6. After submission of the bid the contractor can re-submit revised bid any number of times but before last time and date of submission of bid as notified.
7. While submitting the revised bid, contractor can revise the rate of one or more item(s) any number of times (he need not re-enter rate of all the items)but before last time and date of submission of bid as notified.
8. When bids are invited in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the bid submitted earlier shall become invalid.
9. Tender fee in form of Demand draft (Drawn in favour of **Director, FRI Dehradun**) shall be scanned and uploaded to the e-Tendering website within the period of submission. **The receipt of tender fee shall also be uploaded to the e-**



Tendering website by the intending bidder upto the specified bid submission date and time.

10. Earnest Money in the form of Demand Draft or pay order or Banker's Cheque or Deposit at call Receipt or fixed Deposit (Drawn in favour of **Director, FRI Dehradun**) shall be scanned and uploaded to the e-Tendering website within the period of submission. **The original EMD should be deposited in the office of Head, Engineering & Services Division, FRI within the period of bid submission. (The EMD document shall be only payable at Dehradun).**

The receipt of EMD shall also be uploaded to the e-Tendering website by the intending bidder up-to the specified bid submission date and time.

Copy of Enlistment Order and certificate of work experience and other documents as specified in the press notice shall be scanned and uploaded to the e- Tendering website within the period of bid submission.

However, certified copy of all the scanned and uploaded documents as specified in press notice shall have to be submitted by the lowest bidder only within a week physically in the office of tender opening authority.

Online bid documents submitted by intending bidders shall be opened only of those bidders, whose original EMD deposited Head, Engineering & Ser. Division office and other documents scanned and uploaded are found in order.

The bid submitted shall be opened **11-03-2016 at 03:00 PM**

11. The bid submitted shall become invalid if:
- (i) **The bidder is found ineligible.**
 - (ii) **The bidder does not deposit original EMD and tender fee with office of the Head, Engineering & Services Division, FRI (The EMD and tender fee shall only be payable at Dehradun).**
 - (iii) **The bidder does not upload all the documents (VAT registration /Sales Tax Registration) as stipulated in the bid document **including the copy of receipt for deposition of original EMD.****
 - (iv) **If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted by the lowest bidder in the office of tender opening authority.**
 - (v) **If a tenderer quotes nil rates against each item in item rate tender or does not quote any percentage above/below on the lowest amount of the tender or any section/sub head in percentage rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer.**



12. Intending Bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their bid. A bidder shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The bidder shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a bid by a bidder implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.
 13. The competent authority does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.
 14. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable to rejection.
 15. The competent authority on behalf of Director, FRI Dehradun reserves to himself the right of accepting the whole or any part of the bid and the bidder shall be bound to perform the same at the rate quoted.
 16. No Engineer of gazetted rank or other gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as a contractor for a period of one year after his retirement from Government service, without the previous permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the bid or engagement in the contractor's service.
 17. The bid for the works shall remain open for acceptance for a period of **Ninety (90) days** from the date of opening of bids. If any bidder withdraws his bid before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the bid which are not acceptable to the department, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid. Further the bidder shall not be allowed to participate in the rebidding process of the work.

18. This notice inviting Bid shall form a part of the contract document. The successful bidder/contractor, on acceptance of his bid by the Accepting Authority shall within 15 days from the stipulated date of start of the work, sign the contract consisting of:-
- a) The Notice Inviting Bid, all the documents including additional conditions, specifications and drawings, if any, forming part of the bid as uploaded at the time of invitation of bid and the rates quoted online at the time of submission of bid and acceptance thereof together with any correspondence leading thereto.
 - b) Standard C.P.W.D. **Form 7** or other Standard C.P.W.D. Form as mentioned.

- 1 Separate schedule of quantity is included in this tender for civil and electrical items of work. If the tenderer wants to offer any unconditional rebates on their rates, the same should also be offered in the respective components of civil and electrical schedule separately. The contractor shall quote the items rates in figures and words accurately so that there is no discrepancy in rates written in figures and words.
- 2 Time allowed for the execution of work is **30 days**.
- 3 The contractor(s) shall submit a detailed program of execution in accordance with the master programme/milestone within ten days from the date of issue of award letter.
- 4 Quality of the project is of utmost importance. This shall be adhered to in accordance with the provisions of CPWD specifications and guidelines given in the relevant paras.
- 5 The contractor (s) shall make his own arrangements for electricity and water required for the execution of work.
- 6 Contractor has to deploy required Plant and machinery on the project. Minimum number of plant and machinery to be deployed by him is indicated in this NIT. However, if any additional type and number of plants and machines are required at site, the same shall be deployed by the agency without any extra cost which shall be in order to adhere to the time schedule, as specified in this NIT. In case the contractor fails to deploy the plant and machinery whenever required and as per the direction of the officer-in-charge, he (officer-in-charge) shall be at a liberty to get the same deployed at the risk and cost of the contractor.
- 7 The contractor shall submit the running bills in the shape of the computerized MB in pages of A-4 size as per the standard format of department and shall act as per modified clause 6A of CPWD-7.
- 8 The officer inviting tenders shall have the right of rejecting all or any of the tenders and will not be bound to accept the lowest or any other tender.
- 9 In the case of any tender where unit rate of any item / items appear unrealistic, such tender will be considered as unbalanced and in case the



tenderer in unable to provide satisfactory explanation such a tender is liable to be disqualified and rejected.

- 10 The Security deposit 10% of work done will be deducted from the each bill amount and will be release after completion of defect liability period of the work.
- 11 On acceptance of the tender, the name of the accredited representative(s) of the contractor who would be responsible for taking instructions from the Officer-in-Charge shall be communicated in writing to the officer-in-charge.
- 12 Sales Tax/VAT, purchase tax, turnover tax or any other tax on material in respect of this contract shall be payable by the Contractor and Government will not entertain any claim whatsoever in respect of the same.
- 13 The contractor shall give a list of both Gazetted and Non-Gazetted CPWD employees related to him, if applicable.
- 14 The tender for maintenance work includes in addition to building work all other works such as sanitary and water supply installations drainage installation, electrical work, horticulture work, roads and paths etc. The tenderer apart from being a registered contractor (B&R) of appropriate class, must associate himself with agencies of appropriate class which are eligible to tender for sanitary and water supply drainage, electrical and horticulture works in the composite tender.
- 15 The contractor shall comply with the provisions of the Apprentices Act 1961, and the rules and orders issued there under from time to time. If he fails to do so, his failure will be a breach of the contract and the Head/Officer-in-Charge Engineering & Services Division may in his discretion, without prejudice to any other right or remedy available in law, cancel the contract. The contractor shall also be liable for any pecuniary liability arising on account of any violation by him of the provisions of the said Act.



ADDITIONAL CONDITIONS

1. Unless otherwise provided in the Schedule of Quantities/Specifications, the rates tendered by the contractor shall be all inclusive and shall apply to all heights, lifts, leads and depths of the work and nothing extra shall be payable to him on account of the same. Extra payment for centering/shuttering, if required to be done for heights greater than 3.5 m shall however be admissible at the rates arrived at in accordance with clause 12 of the agreement, if not already specified.
2. The contractor shall make his own arrangement for obtaining electric connection(s) if required and make necessary payments directly to the department concerned.
3. Other agencies doing works related with this project may also simultaneously execute their works and the contractor shall afford necessary facilities for the same. The contractor shall leave such necessary holes, openings etc. for laying/burying in the work, pipes cables, conduits, clamps, boxes and hooks for fan clamps etc. as may be required for the other agencies. Nothing extra over the Agreement rates shall be paid for doing these.
4. Some restrictions may be imposed by the security staff etc. on the working and for movement of labour, materials etc. The contractor shall be bound to follow all such restrictions/instructions and nothing extra shall be payable on account of the same.
5. The contractor shall fully comply with all legal orders and directions of the Public or local authorities or municipality and abide by their rules and regulations and pay all fees and charges for which he may be liable in this regard. Nothing extra shall be paid/reimbursed for the same.
6. If as per local Municipal regulations, huts for labour are not to be erected at the site of work; the contractor shall be required to provide such accommodation at a place as is acceptable to the local body and nothing extra shall be paid on this account.
7. The structural and architectural drawings shall at all times be properly co-related before executing any work. However, in case of any discrepancy in the item given in the schedule of quantities appended with the tender and Architectural drawings relating to the relevant item, the former shall prevail unless otherwise given in writing by the officer-in-charge.
8. The contractor shall bear all incidental charges for cartage, storage and safe custody of materials issued by department.
9. Samples of various materials required for testing shall be provided free of charges by the contractor. Testing charges, if any, unless otherwise provided shall be borne by the department. All other expenditure required to be incurred for taking the samples; conveyance, packing etc. shall be borne by the contractor himself.
10. For the purpose of recording measurements and preparing running account bills, the abbreviated nomenclature indicated in the publications Abbreviated



Nomenclature of Items of DSR 2014 shall be accepted. The abbreviated nomenclature shall be taken to cover all the materials and operations as per the complete nomenclature of the relevant items in the agreement and relevant specifications.

In case of items for which abbreviated nomenclature is not available in the aforesaid publication and also in case of extra and substituted items for which abbreviated nomenclature are not provided for in the agreement, full nomenclature of item shall be reproduced in the measurement books and bill forms for running account bills.

For the final bill, however, full nomenclature of all the items shall be adopted in preparing abstract in the measurement books and in the bill forms.

11. The contractor shall have to make approaches to the site, if so required and keep them in good condition for transportation of labour and materials as well as inspection of works by the officer in charge. Nothing extra shall be paid on this account.
12. No payment will be made to the contractor for damage caused by rains, or other natural calamities during the execution of the works and no such claim on this account will be entertained.
13. The contractor shall take instructions from the officer-in-charge for stacking of materials. No excavated earth or building materials etc. shall be stacked/collected in areas where other buildings, roads, services, compound walls etc. are to be constructed.
14. Any trenching and digging for laying sewer lines/water lines/cables etc. shall be commenced by the contractor only when all men, machinery's and materials have been arranged and closing of the trench(s) thereafter shall be ensured within the least possible time.
15. It shall be ensured by the contractor that no electric live wire is left exposed or unattended to avoid any accidents in this regard.
16. The contractor shall maintain in perfect condition, all portions executed till completion of the entire work allotted to him. Where however phased delivery of work is contemplated these provisions shall apply separately to each phase.
17. The entire royalty at the prevalent rates shall have to be paid by the contractor on all the boulders, metals, shingle sand etc. collected by him for execution of the work, directly to the Revenue authority or authorized agents of the State Government concerned or the Central Government, as the case may be.
18. Various factory made materials shall be procured from reputed and approved manufacturers or their authorized dealers. Decision of officer in charge in this regard shall be final and binding.
19. It must be ensure that all materials to be used in work bear BIS certification mark. In cases where BIS certification system is available for a particular material/product but not even a single producer has so far approached BIS for certification the material can be used subject to the condition that it should confirm to CPWD specification and relevant BIS codes. In such case written



approval of the Technical sanctioning Authority may be obtained before use of such material in the work.

20. Contractor shall have to execute a Guarantee Bond in respect of Water Proofing works as per Performa attached in this N.I.T. He shall also have to execute guarantee bonds for water supply and sanitary installations work on the Performa attached in this NIT.
 21. The terms machine batched, machine mixed and machine vibrated concrete used elsewhere in agreement shall mean the concrete produced in concrete batching and mixing plant and if necessary transported by transit concrete mixers, placed in position by the concrete pumps, tower crane and vibrated by surface vibrator /needle vibrator / plate vibrator, as the case may be to achieve required strength and durability.
 22. Wherever work is specified to be done or material procured through specialized agencies, their names shall be got approved well in advance from officer in charge.  23. The contractor or his authorized representative shall associate in collection, preparation, forwarding and testing of such samples. In case, he or his authorized representative is not present or does not associate him, the results or such tests and consequences thereon shall be binding on the contractor.
 24. The contractor shall get the water tested with regard to its suitability of use in the works and get written approval from the Officer-in-charge before he proceeds with the use of same of execution of works. If the tube-well water is not suitable, the contractor shall arrange Municipal water or from any other sources at his own cost and nothing extra shall be paid to the contractor on this account. The water shall be got tested at frequency specified in latest CPWD specifications/BIS code.
- 37. Till the work is almost completed to the satisfaction of Officer-in-charge**
- a. Contractor shall not divert any advance payments or part thereof for any other purpose other than needed for completion of the contracted work. All advance payments received as per terms of the contract (i.e. mobilization, secured against materials brought at site, secured against plant & machinery and / or for work done during interim stages, etc) are required to be re-invested in the contracted work to ensure advance availability resources in terms of materials, labour, plant & machinery needed for required pace of progress for timely completion of work.



- b. All running account bills preferred by the contractor for advance payments shall be processed only if **Officer- in- charge** is satisfied that up-to date investments made by the contractor against contracted work are more than the payments received. Accordingly, all running account bills shall be supported with an account of update payments received vis-à-vis up-to date investments made on the work to enable Officer-in-charge to check to his satisfaction that the payments made by officer in charge are properly utilized only on the work and nowhere else”.



GENERAL CONDITIONS

1. The contractor (s) shall inspect the site of work before tendering and acquaint himself with the site conditions and no claim on this account shall be entertained by the department.

The contractor (s) shall get himself acquainted with nature and extent of the work and satisfy himself about the availability of materials from kiln or approved quarries for collection and conveyance of materials required for construction.
 2. The contractor (s) shall study the soil investigation report for the site, available in the office of the **Officer-in-charge** and satisfy him about complete characteristics of soil and other parameters of site. However, no claim on the alleged inadequacy or incorrectness of the soil data supplied by the department shall be entertained.
 3. The tenderer shall see the approaches to the site. In case any approach from main road is required by the contractor, the same shall be provided, improved and maintained by the contractor at his own cost. No payment shall be made on this account.
 4. The contractor (s) shall give to the Municipality, Police and other authorities all necessary notices etc. that may be required by law and obtain all requisite Licenses for temporary obstructions, enclosures etc. and pay all fee, taxes and charges which may be livable on account of these operations in executing the contract. He shall make good any damage to the adjoining property whether public or private and shall supply and maintain light and other illumination on for cautioning the public at night.
 5. The contractor shall take all precautions to avoid accidents by exhibiting necessary caution boards day and night speed limit board's red flags, red lights and providing barriers. He shall be responsible for all dangers and incidents caused to existing / new work due to negligence on his part. No hindrances shall be caused to traffic during the execution of the work.
 6. The contractor shall provide at his own cost suitable weighing surveying and leveling and measuring arrangements as may be necessary at site for checking. All such equipments shall be got calibrated in advance from laboratory, approved by the **Officer-In-Charge**. Nothing extra shall be payable on this account.
 7. Contractor shall provide permanent bench marks and other reference points for the proper execution of work and these shall be preserved till the end of work. All such reference points shall be in relation to the levels and locations, given in the Architectural and plumbing drawings
 8. The contractor shall submit for the approval of **Officer-in-Charge** names of specialized agencies of repute along with their technical capacity proposed to be engaged by him for executing specialized works, who must have executed satisfactorily works of value as specified in mandatory conditions.
 9. The contractor shall take all precautions to avoid accidents by, exhibiting caution boards day and night, speed limit boards, red flags, red light and providing

necessary barriers and other measures required from time to time. The contractor shall be responsible for all damages and accidents due to negligence on his part.

10. Other agencies will also simultaneously execute and install the works of electrification, air conditioning, lifts, fire-fighting etc. for this work and the contractor shall provide necessary facilities for the same. The contractor shall leave such recesses, holes openings etc. as may be required for the electric, air-conditioning and other related works (for which inserts, sleeves, brackets, conduits base pinion, clamps etc. shall be supplied free of cost by the department unless otherwise specifically mentioned) and the contractor shall fix the same at time of casting of concrete, stone work & brick work, if required and nothing extra shall be payable on this account.
11. All materials obtained from Govt. stores or otherwise shall be get checked by the **Officer- in -charge** or his any authorized supervisor staff on receipt of the same at site before use.
12. The contractor shall conduct work so as not to interfere with or hinder the progress or completion of the work being performed by other contractor(s) or by the **Officer- in-charge** and shall as far as possible arrange his work and shall place and dispose of the materials being used or removed so as not to interfere with the operations of other contractor or he shall arrange his work with that of the others in an acceptable and coordinated manner and shall perform it in proper sequence to the complete satisfaction of others.
13. *Existing drains, pipes, cables, over-head wires, sewer lines, water lines and similar services encountered in the course of the execution of work shall be protected against the damage by the contractor at his own expense. The contractor shall not store materials or otherwise occupy any part of the site in a manner likely to hinder the operation of such services.*
14. A reference made to any Indian Standard specification in these documents, shall imply to the latest version of that standard. Including such revision/amendments as issued by the bureau of Indian standard up-to last date of receipt of tenders. The contractor shall keep at his own cost all such publications of relevant Indian standard applicable to the work at site.

3. Samples of all materials and fittings to be used in the work in respect of brand manufacturer and quality shall be got approved from the **Officer-in-charge**, well in advance of actual execution and shall be preserved till the completion of the work. Articles bearing BIS certifications mark shall only be used unless no manufacturer has got BIS mark for the particular material. Any material/fitting whose sample has not been approved in advance and any other unapproved material brought by the contractor shall be immediately removed as soon as directed.
4. The rates for all items of work shall unless clearly specialized otherwise include cost of all labour, material tools and plants and other inputs involved in the execution of the item.
5. The contractor (s) shall quote all inclusive rates against the items in the schedule of quantities and nothing extra shall be payable for any of the conditions and specifications mentioned. In the tender documents unless specifically specified otherwise.
6. Unless otherwise specified in the schedule of quantities the rates for all items shall be considered as inclusive of pumping/baling out water, if necessary, for which no extra payment shall be made. Those conditions shall be considered to include water from any source such as inflow of flood, surface and sub-soil water etc. and shall apply to the execution in any season



MATERIAL AND QUALITY ASSURANCE OF THE WORK

1. The contractor shall ensure quality control measures on different aspects of construction including materials, workmanship and correct construction methodologies to be adopted. He shall have to submit quality assurance programme within two weeks of the award of work. The quality assurance programme should include method statement for various items of work to be executed along with check lists to enforce quality control.
2. The contractor shall get the source of all other materials, not specified elsewhere in the document, approved from the **Officer-in-charge**. The contractor shall stick to the approved source unless it is absolutely unavoidable. Any change shall be done with the prior approval of the **Officer-in-charge** for which tests etc. shall be done by the contractor at his own cost. Similarly, the contractor shall submit brand/ make of various materials not specified in the agreement, to be used for the approval of the **Officer-in-charge** along with samples and once approved, he shall stick to it.
3. **Test Laboratories :**

A). Laboratory at Site:

The contractor shall provide at site, the testing equipment and materials for the field tests mentioned in the list of mandatory tests given in CPWD specifications 2009 Vol. 1 & 2 at his own cost. Nothing extra shall be payable to him on this account. In all cases, cost of samples and to and fro carriage shall be borne by the contractor.

The representatives of the department shall be at liberty to inspect the testing facilities at site and conduct testing at random in consultation with **Officer-in-charge**. The contractor shall provide all necessary facilities for the purpose. The laboratory shall be equipped, inter alia, with the following equipments:

a) Balances:

- i) 7 kg to 10 kg capacity, semi-self indicating type – Accuracy 10 gm.
- ii) 500 gm capacity, semi-self indicating type Accuracy 1 gm.
- iii) Pan Balance- 5 kg Capacity - Accuracy 10 gm.

b) Ovens- Electrically operated, thermostatically controlled up-to 1100C: Sensitivity 10C.

c) Sieves: as per IS: 460

- i) IS Sieves – 450 mm internal dia of sizes 100 mm, 80 mm, 63 mm, 50 mm, 40 mm, 25 mm, 20 mm, 12.5 mm, 10 mm, 6.3 mm, 4.75 mm, complete with lid and pan.



- ii) IS Sieves – 200 mm internal dia (brass frame) consisting of 2.36 mm, 1.18 mm, 500 microns, 425 microns, 300 microns, 212 microns, 150 microns, 90 microns, 75 microns with lid and pan.
- d) Sieve shaker capable of 200 mm and 300 mm dia sieves, manually operated with timing switch assembly.

All test which can be performed in the site lab with above equipments shall be done at site except that at least 10% testing of materials shall be got done from external laboratories. However, for the tests to be carried out by the external laboratories, the contractor shall supply free of charge all the materials required for testing, including transportation. The testing charges shall be borne by the Contractor / Department in the manner described in Para-B below.

B) Other Laboratories :

The contractor shall arrange carrying out of all tests required under the agreement through the laboratory as approved by the officer in charge and shall bear all charges in connection therewith including fee for testing. The said cost of tests shall be borne by the contractor/department in the manner indicated below.

- i) By the contractor, if the results show that the test does not conform to relevant CPWD Specifications / BIS code or specification mentioned elsewhere in the documents
- ii) By the department, if the results conform to relevant CPWD Specifications / BIS code or specification mentioned elsewhere in the documents.

However, no testing charges will be payable by the contractor for the tests conducted in CPWD laboratories.

If the tests, which were to be conducted in the site laboratory, are conducted in other laboratories for whatever the reasons, the cost of such tests shall be borne by the contractor.

4. Sampling of Materials :

Sample of building materials fittings and other articles required for execution of work shall be got approved from the **Officer-in-charge**. Articles manufactured by companies of repute and approved by the **Officer-in-charge** shall only be used. Articles bearing BIS certification mark shall be used in case the above are not available, the quality of samples brought by the contractor shall be judged by standards laid down in the relevant BIS specifications. All materials and articles brought by the contractor to the site for use shall conform to the samples approved by the **Officer-in-charge** which shall be preserved till the completion of the work.

- 5. The contractor shall ensure quality construction in a planned and time bound manner. Any sub-standard material/work beyond set out tolerance limit shall be summarily rejected by the **Officer-in-charge**



6. BIS marked materials except otherwise specified shall be subjected to quality test at the discretion of the **Officer-in-charge** besides testing of other materials as per the specifications described for the item/materials. Wherever BIS marked materials are brought to the site of work, the contractor shall if required, by the **Officer-in-charge** furnish manufacturers test certificate or test certificate from approved testing laboratory to establish that the material produced by the contractor for incorporation in the work satisfies the provisions of BIS codes relevant to the material and/or the work done.
7. The contractor shall procure all the materials at least in advance so that there is sufficient time to testing and approving of the materials and clearance of the same before use in work.
8. All materials brought by the contractor for use in the work shall be got checked from the **Officer-in-charge** or his authorized representative of the work on receipt of the same at site before use.
9. The contractor shall be fully responsible for the safe custody of the materials issued to him even if the materials are in double lock and key system.
10. **QUALITY & QUARRIES OF STONE AGGREGATE & SAND**

The Stone aggregate/stone shall be brought from quarries as approved by the Engineer-in-charge, as shown below against each or any other quarry. The materials shall however confirm to CPWD specifications.

11. **Outside /Independent Testing Facilities**

Extensive testing of the materials used for construction is a pre-requisite for attaining high quality of the work. This shall also require specialized tests, physical, chemical, ultrasonic, x-ray and various other types of tests which



cannot possibly be carried out in a site laboratory. These tests also require specialized personnel who regularly deal in such testing. Therefore the need arises for carrying out the tests in outside laboratories. These laboratories may be in the Government sector, Semi Government or Private sector.

All govt. Institutes, Institutes of Technology, National Institutes of Technology, Central and State research Centers, Centrally and State funded laboratories stands approved. No approval is required for testing in these laboratories/institutes. However, the outside private laboratories shall be approved in the following manner:

- 1. The Director, FRI Dehradun will approve the private lab on the recommendation of Chief Engineer if no approved labs as above are available within 200 km of the work site. A particular private Lab will be approved for specified tests and work/project. Approving authority will specify the tests while approving the laboratory.**
- 2. A lab will have to submit details of space available, equipments, staff (Technical and non Technical), Accreditation and approval from various department/institutes. Lab must be NABL approved.**
- 3. Initial approval of lab should be for one year and can be revalidated for further one year and so on.**
- 4. Every lab will be audited for maintenance and calibration of equipments and employment of staff prior to approval/revalidation.**

However, testing of material in any Govt. Lab/Public Undertaking Lab/IIT or NIT Lab/Government Engineering College may be allowed by Officer-in-Charge without prior approval of higher officers provided these labs have all necessary facility to carry out the required tests.-



PARTICULAR SPECIFICATIONS

4.0 ROAD WORK

Road work shall conform to CPWD specification 2009, in case the same is not available in CPWD specification or if required as per item, the MORTH specifications for roads and bridges 2001 shall be followed.

1. All work shall be carried out as per CPWD specification will be followed wherever mentioned in bill of quantities or as per direction of Officer-In-Charge.
2. The material collected for use in the work shall satisfy all requirements for the particular work, failing which the material will be rejected. The gauge of stone ballast shall be as per detailed CPWD specification for the respective item.
3. Power shall be reserved with the department to accept the tender in part or full without the assigning of any reason for which no claimed of Contractor shall be entertained.
4. The quantities are liable to wide variation on either side for which no extra claim of the contractor shall be entertained. The numbers of Kms and location may be changed.
5. The fully computerized HMP should not be located beyond 30 Km. radius from the site of work.
6. The Contractor shall have to work as per programme of the department. No claim, whatsoever shall be entertained on this account.
7. All the measurement shall be done as CPWD detailed specification amended and corrected up to date.
8. Contractor shall have to inform the department in writing the name of his authorized representative and specimen signature of the authorized representative would be furnished in writing.
9. All the receipt and issues signed by the contractor or his authorized representative shall be conclusive proof of the delivery of material.
10. Site order book will kept at the site of work and plant in which instructions officers shall be recorded by the Officer-In-charge inspecting officers or his representative. The contractor or his authorized representative will be required to sign the site order book daily in acknowledgement to the instructions and shall be bound to comply with the instruction.



11. The contractor shall be bound to pay wages to labourers which shall not be less than the wages approved under prevalent labour laws.
12. No equipment or personal employed at site shall be removed from site without permission of Officer-In-Charge.
13. Contractor has to arrange all the material such as aggregate cement, sand steel interlocking tiles, kerb stone etc. and labour. The rate shall be inclusive of all taxes royalty, carriage stacking, wages etc. nothing shall be extra cover the accepted over tender rate.
14. The contractor shall be required to give run of the equipment for establishment their capabilities to achieve the led down specification to the satisfaction of Officer-In-Charge before commencement of the work.
15. All the equipment shall be proper efficiency and shall be operated and maintained at all times in a manner acceptable to the Officer-In-Charge.
16. All the work shall be carried out as per CPWD detailed specification and instruction issued time to time by higher authorities and as per direction of Officer-In-Charge.
17. The tenderer are advised to see the site of work and fully acquaint themselves about the condition with regard to the site, availability of materials suitable location for installation of plant construction of godowns, stores and labour huts the extent of leads and lifts involved in the work over the entire duration of contract including local conditions, traffic restrictions, obstruction and other condition as required for satisfactory execution of the work. His rate should take into consideration all the above factors and contingency. No claim whatsoever shall be entertained by the department on this account. The land for installation of plants, construction of godowns labour sheds laboratory sheds, site office etc. will have to arrange by the contractor himself at his own cost and keeping in view that the maximum distance from site of work to plant should not be more than 30 Kms for which no extra payment shall be made. The mix plant shall not be located beyond 30 Km. distance from the site of work in any case.
18. In given rates tendered are advised to take into account fluctuations in market rate. No claim shall be entertained on this account during pandect of the tender and currency of the contract.
19. All entries by the tenderer should be in one ink and in one hand writing. Eraser and over wiring/ cutting should be avoided as far as possible. However all



- corrections and over writing shall have to be signed by the tenderer. In case of variation in rates written in words and in figures , lower of the two will be considered for acceptance.
20. In case of firm tender must be signed by each partner or member or by the person holding the power of attorney on behalf of all other partner/members of the firm. In letter case a copy of the power of attorney attested by the Gazette officer must accompany with the tender.
 21. No claim for extra payment shall be entertained on account of delay in supply of materials or machineries by the department.
 22. The contractor must write their correct and complete address in tender and arrange to take delivery of all letters if any letter is received back undelivered it shall be contractor 's own responsibility and contractor shall be bound for such action as may be required through the contents of such letters.
 23. In case work is stopped by the department due to bad/cold weather or any other reason, suitable extension of time may be given to the contractor.
 24. Not completing the work in time the contractor might to require to work in two shifts and no claim whatsoever shall be entertained on this account notwithstanding fact that the contractor shall have to pay the labourers and other staff engaged directly or indirectly on the work according to the provision of the labour Act. Regulation and agreement entered upon and /or extra amount for any other reason. If work is done in night/ dark, sufficient lighting arrangement at laying site and Hot mix plant, site shall have be arranged by contractor at his own cost for which no extra payment shall be made.
 25. The contractor must get acquainted with proposed site for the work and study specification on condition carefully before tendering.
 26. Rejected material not accordance to the specification shall have to be removed by the contractor at his own cost at site of work. If the contractor fails to comply with the orders the same shall be removed by the department at cost of contractor.
 27. The contractor shall be responsible for any damage to work or materials due to natural calamities or by the other means or theft irrespective of the running payment made to him and no claim whatsoever shall be entertained.
 28. The Contractor shall require producing of all road materials such as aggregate & Bitumen etc. Sufficiently in advance to obtain the approved of Officer-In-
-



Charge before commencing the work. The job Mix formula will be based on approved materials. Subsequently the materials to be used in actual execution of the work shall strictly confirm to the quality of samples approved . In case of variations such materials shall liable to rejection.

29. The contractor shall at time carry out work on highway in manner creating least interference and inconvenience to the flow of traffic and shall take all necessary measures for the safety of traffic during construction and provide, erect and maintain such barricades, including signs marking flags, lights and flagmen as necessary at inner and of the work site and at such intermediate points as direction by the Officer-In-Charge for the proper edification of construction areas. The temporary warring lamps shall be installed at all barricades during the hour of darkness and kept it all times during those hour. The contractor shall be responsible for any damage or accidents are caused due to negligence on his part.
30. The contractor shall intimate to the Officer-In-Charge in writing before the start of the work of job mix formula design mixed to be used by him for the work after getting it designed/tested form institute/laboratory by the department at his (contractor) own cost. The approved job mix formula shall remain affective unless and until modified by the Officer-In-Charge should a change in the source of materials be proposed a job mix formula shall be established and got approved from the Officer-In-Charge before actually using these materials.
31. The arrangement for tools, plants and materials will be made by the contractor for all the quality control tests required to be carried out regularly at site of work and plant site as per specification noting extra will be paid for this.
32. In case Officer-In-Charge desires some of quality control test or design of mix to be carried out in the laboratory of P.W.D/ Central Road Research Institute, New Delhi or any other laboratory approved by him, the contractor shall make all arrangements for collecting , preparing and forwarding the required samples to such as desired by the Officer-In-Charge at his own cost. The testing charge in such cases shall however be borne by the department. The contractor or his authorized representative shall remain in contact with the Officer-In-charge for associating all such operations. In case he or his authorized representative is not present or does not associate himself, the result of such test and consequence there on shall be binding on the contractor.

The mix shall be laid according of the L- section and across section as per direction of Officer-In-Charge. Compaction of mix shall be done to achieve required density as per CPWD specifications.



33. The Hot mix brought laying site ready to lay shall be liable to any kind of viz sieve Test and Temperature test and any materials found below standards in any way shall be rejected in whole tipper without entertaining any claim of the contractor on this account cost of material (Bulk Bitumen & Aggregate) if issued by department shall recovered from the contractor.
34. Quality control shall be according CPWD specification fail in which necessary deductions shall be done according to the rules to CPWD in case of any dispute or difference of opinions the decision of Head Engineering Cell shall be final and binding on the contractor.
35. Any recovery imposed by TAC or any authorities shall be recovered from contractor.
36. During the inspection of construction work, if the quality of work found not at par Or excess payment is made after total measurement and due to this there is loss to the Institute then 50% of the recovery of that loss will be made from the concerned contractor.
37. I/We have gone through all condition specification Bill of Quantity of the contract and others to execute the above items on the quoted rates by me/us in the above Bill of Quality.

BETWEEN

DIRECTOR, FRI DEHRAUN represented through Head, Engineering & Services Division, (Name of Division) FRI, (Address of Division), (Hereinafter referred as the '**Principal/Owner**', which expression shall unless repugnant to the meaning or context hereof include its successors and permitted assigns)

AND

..... (Name and Address of the Individual/firm/Company) through (Hereinafter referred to as the (Details of duly authorized signatory) "**Bidder/Contractor**" and which expression shall unless repugnant to the meaning or context hereof include its successors and permitted assigns)

Preamble

WHEREAS the Principal / Owner has floated the Tender (NIT No.) (Hereinafter referred to as "**Tender/Bid**") and intends to award, under laid down organizational procedure, contract for (Name of work) hereinafter referred to as the "**Contract**".

AND WHEREAS the Principal/Owner values full compliance with all relevant laws of the land, rules, regulations, economic use of resources and of fairness/transparency in its relation with its Bidder(s) and Contractor(s).

AND WHEREAS to meet the purpose aforesaid both the parties have agreed to enter into this Integrity Agreement (hereinafter referred to as "**Integrity Pact**" or "**Pact**"), the terms and conditions of which shall also be read as integral part and parcel of the Tender/Bid documents and Contract between the parties.

NOW, THEREFORE, in consideration of mutual covenants contained in this Pact, the parties hereby agree as follows and this Pact witnesses as under:



Article 1: Commitment of the Principal/Owner

- 1) The Principal/Owner commits itself to take all measures necessary to prevent corruption and to observe the following principles:
 - (a) No employee of the Principal/Owner, personally or through any of his/her family members, will in connection with the Tender, or the execution of the Contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitled to.
 - (b) The Principal/Owner will, during the Tender process, treat all Bidder(s) with equity and reason. The Principal/Owner will, in particular, before and during the Tender process, provide to all Bidder(s) the same information and will not provide to any Bidder(s) confidential / additional information through which the Bidder(s) could obtain an advantage in relation to the Tender process or the Contract execution.
 - (c) The Principal/Owner shall endeavor to exclude from the Tender process any person, whose conduct in the past has been of biased nature.
- 2) If the Principal/Owner obtains information on the conduct of any of its employees which is a criminal offence under the Indian Penal code (IPC)/Prevention of Corruption Act, 1988 (PC Act) or is in violation of the principles herein mentioned or if there be a substantive suspicion in this regard, the Principal/Owner will inform the Chief Vigilance Officer and in addition can also initiate disciplinary actions as per its internal laid down policies and procedures.

Article 2: Commitment of the Bidder(s)/Contractor(s)

- 1) It is required that each Bidder/Contractor (including their respective officers, employees and agents) adhere to the highest ethical standards, and report to the Government / Department all suspected acts of **fraud or corruption or Coercion or Collusion** of which it has knowledge or becomes aware, during the tendering process and throughout the negotiation or award of a contract.
- 2) The Bidder(s)/Contractor(s) commit himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the Tender process and during the Contract execution:
 - a) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm, offer, promise or give to any of the Principal/Owner's employees involved in the Tender process or execution of the Contract or to any third person any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the Tender process or during the execution of the Contract.



- b) The Bidder(s)/Contractor(s) will not enter with other Bidder(s) into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict Competitiveness or to cartelize in the bidding process.
- c) The Bidder(s)/Contractor(s) will not commit any offence under the relevant IPC/PC Act. Further the Bidder(s)/Contract(s) will not use improperly, (for the purpose of competition or personal gain), or pass on to others, any information or documents provided by the Principal/Owner as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
- d) The Bidder(s)/Contractor(s) of foreign origin shall disclose the names and addresses of agents/representatives in India, if any. Similarly Bidder(s)/Contractor(s) of Indian Nationality shall disclose names and addresses of foreign agents/representatives, if any. Either the Indian agent on behalf of the foreign principal or the foreign principal directly could bid in a tender but not both. Further, in cases where an agent participate in a tender on behalf of one manufacturer, he shall not be allowed to quote on behalf of another manufacturer along with the first manufacturer in a subsequent/parallel tender for the same item.
- e) The Bidder(s)/Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the Contract.
- 3) The Bidder(s)/Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.
- 4) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm indulge in fraudulent practice **means a willful misrepresentation or omission of facts or submission of fake/forged documents in order to induce public official to act in reliance thereof, with the purpose of obtaining unjust advantage by or causing damage to justified interest of others and/or to influence the procurement process to the detriment of the Government interests.**
- 5) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm use Coercive Practices (means the act of obtaining something, compelling an action or influencing a decision through intimidation, threat or the use of force directly or indirectly, where potential or actual injury may befall upon a person, his/ her reputation or property to influence their participation in the tendering process).
-



Article 3: Consequences of Breach

Without prejudice to any rights that may be available to the Principal/Owner under law or the Contract or its established policies and laid down procedures, the Principal/Owner shall have the following rights in case of breach of this Integrity Pact by the Bidder(s)/Contractor(s) and the Bidder/ Contractor accepts and undertakes to respect and uphold the Principal/Owner's absolute right:

- 1) If the Bidder(s)/Contractor(s), either before award or during execution of Contract has committed a transgression through a violation of Article 2 above or in any other form, such as to put his reliability or credibility in question, the Principal/Owner after giving 14 days notice to the contractor shall have powers to disqualify the Bidder(s)/Contractor(s) from the Tender process or terminate/determine the Contract, if already executed or exclude the Bidder/Contractor from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of transgression and determined by the Principal/Owner. **Such exclusion may be forever or for a limited period as decided by the Principal/Owner.**
- 2) **Forfeiture of EMD/Performance Guarantee/Security Deposit:** If the Principal/Owner has disqualified the Bidder(s) from the Tender process prior to the award of the Contract or terminated/determined the Contract or has accrued the right to terminate/determine the Contract according to Article 3(1), the Principal/Owner apart from exercising any legal rights that may have accrued to the Principal/Owner, may in its considered opinion forfeit the entire amount of Earnest Money Deposit, Performance Guarantee and Security Deposit of the Bidder/Contractor.
- 3) **Criminal Liability:** If the Principal/Owner obtains knowledge of conduct of a Bidder or Contractor, or of an employee or a representative or an associate of a Bidder or Contractor which constitutes corruption within the meaning of IPC Act, or if the Principal/Owner has substantive suspicion in this regard, the Principal/Owner will inform the same to law enforcing agencies for further investigation.

Article 4: Previous Transgression

- 1) The Bidder declares that no previous transgressions occurred in the last 5 years with any other Company in any country confirming to the anticorruption approach or with Central Government or State Government or any other Central/State Public Sector Enterprises in India that could justify his exclusion from the Tender process.
- 2) If the Bidder makes incorrect statement on this subject, he can be disqualified from the Tender process or action can be taken for banning of business dealings/ holiday listing of the Bidder/Contractor as deemed fit by the Principal/ Owner.



- 3) If the Bidder/Contractor can prove that he has resorted / recouped the damage caused by him and has installed a suitable corruption prevention system, the Principal/Owner may, at its own discretion, revoke the exclusion prematurely.

Article 5: Equal Treatment of all Bidders/Contractors/Subcontractors

- 1) The Bidder(s)/Contractor(s) undertake(s) to demand from all subcontractors a commitment in conformity with this Integrity Pact. The Bidder/Contractor shall be responsible for any violation(s) of the principles laid down in this agreement/Pact by any of its Subcontractors/sub-vendors.
- 2) The Principal/Owner will enter into Pacts on identical terms as this one with all Bidders and Contractors.
- 3) The Principal/Owner will disqualify Bidders, who do not submit, the duly signed Pact between the Principal/Owner and the bidder, along with the Tender or violate its provisions at any stage of the Tender process, from the Tender process.

Article 6- Duration of the Pact

This Pact begins when both the parties have legally signed it. It expires for the Contractor/Vendor 08 (Eight) Months after the completion of work under the contract or till the continuation of defect liability period, whichever is more and for all other bidders, till the Contract has been awarded.

If any claim is made/lodged during the time, the same shall be binding and continue to be valid despite the lapse of this Pacts as specified above, unless it is discharged/determined by the Competent Authority, CPWD.

Article 7- Other Provisions

- 1) This Pact is subject to Indian Law, place of performance and jurisdiction is the **Head quarters of the Division** of the Principal/Owner, who has floated the Tender.
- 2) Changes and supplements need to be made in writing. Side agreements have not been made.
- 3) If the Contractor is a partnership or a consortium, this Pact must be signed by all the partners or by one or more partner holding power of attorney signed by all partners and consortium members. In case of a Company, the Pact must be signed by a representative duly authorized by board resolution.
- 4) Should one or several provisions of this Pact turn out to be invalid; the remainder of this Pact remains valid. In this case, the parties will strive to come to an agreement to their original intentions.



5) It is agreed term and condition that any dispute or difference arising between the parties with regard to the terms of this Integrity Agreement / Pact, any action taken by the Owner/Principal in accordance with this **Integrity Agreement/ Pact or interpretation thereof shall not be subject to arbitration.**

Article 8- LEGAL AND PRIOR RIGHTS

All rights and remedies of the parties hereto shall be in addition to all the other legal rights and remedies belonging to such parties under the Contract and/or law and the same shall be deemed to be cumulative and not alternative to such legal rights and remedies aforesaid. For the sake of brevity, both the Parties agree that this Integrity Pact will have precedence over the Tender/Contact documents with regard any of the provisions covered under this Integrity Pact.
