In continuation to this office circular of even number, dated 08th May, 2017, vide which all the Scientists working in ICFRE and its Institutes were directed to finalize their Annual Work Plan specifying therein the targets/objectives/goals (in quantitative and other terms, i.e. physical/financial targets) in accordance with Part-2 Sl. No.2 of the APAR format in consultation with concerned reporting authority by 30th May, 2017. It is expected that the same must have been done within the stipulated time frame.

In this connection, it is further directed that:-

- 1. The approved annual work plan for identified 8-10 Key Result Areas (KRA) (targets/objectives/goals in qualitative as well as quantitative terms) at the beginning of the year may be reviewed by the concerned reporting authority in consultation with the concerned scientist again as a mid-year exercise during the month of September/October, 2017. During the mid-year review, the Key Result Areas may undergo some changes from that originally prepared.
- 2. After mid-term review, the final annual work plan for KRA as prescribed in part-2, point-2 of APAR format, should be sent to this office by 31st October, 2017 duly signed by officer reported upon and the concerned reporting authority. This will facilitate an objective assessment of scientists for the purpose of promotion as well as periodically review.
- It is not necessary that KRAs mentioned in the annual work plan should entirely be quantitative in nature. However, it should be clearly defined in qualitative terms with
- 4. In case of a change of reporting officer during the year, the KRAs agreed with the previous reporting officer would continue to apply.
- In case of a scientist taking up a new assignment in the course of the reporting year, such targets/goals shall be set at the time of assumption of the new assignment. The same may be reflected in the APAR of that period.
- These instructions shall be applicable to all the Scientists working in the ICFRE and its Institutes from Scientist 'B' to Scientist 'G'
- 7. From the next year onwards, this exercise is to be carried out at the beginning of the year and finalizing by 30th April and if there is any need for mid-term review, the same may be completed and sent to this office by 31st October every year.
- 8. These instructions be brought to the knowledge of all scientists.
