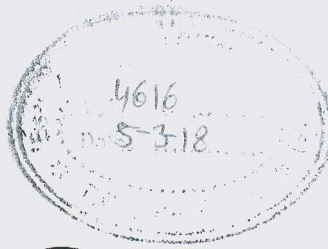

**Sub:- Minutes of the meeting held on 11.01.2018 with representatives of all Service Associations of ICFRE(Hqrs.) / FRI Dehra Dun.**

Madam /Sir,

This is to inform that a meeting was held at the ICFRE (Hqrs.) Dehra Dun on 11.01.2018 with representatives of all Service Associations of ICFRE (Hqrs.) / FRI, Dehra Dun to apprise them about the status of ICFRE Pension Fund. All Service Associations in general and FoSA in particular expressed their reservation on the issues of revolving funds created by Institutes and payment of honorarium by the Institutes from the project funds. These activities have negative impact on the revenue generation which ultimately affect Pension Fund adversely.

2. This is to bring to your kind notice that disbursement of honorarium or additional remuneration is governed by 'Fundamental Rule (11) and (46)(b). It is, requested to intimate if honorarium / additional remuneration are being disbursed from the project funds in your Institute and also to furnish your comments on the issue of disbursement of honorarium to the ICFRE employees and Scientists / officers from the project funds in view of FR 11 and FR 46(b) and its impact on the Pension Fund.

3. In addition, it is also requested to provide details of the revolving fund, if any created by the Institute in the following format:-
