



Other Terms and Conditions for engaging the Medical Officer on contract basis at NFH are as follow:-

Essential Qualifications:

1. MBBS degree from a recognized Institution with permanent registration certificate from Medical Council of India/States.
2. The candidates should not be more than 50 year of age.
3. Preference will be given to the candidates having experience in working as General Physician in any Govt. /Semi Govt. Hospital.
4. Remuneration:-

5. The contract period will normally be for a period of one year which may be extendable on year to year basis by the Director, FRI.
6. The Engagement is purely on contractual basis and it will not confer any rights on the Medical Officer for regular appointment.
7. The Director, Forest Research Institute, Dehradun reserves the right to terminate the contract before expiry of the terms by giving one month's notice to the Medical Officer.
8. The Director, FRI reserves the right not to fill the advertised post without assigning any reason
9. The Duty hours will be similar to other Medical Officers at New Forest Hospital. He/she will be entitled to avail two days leave per month only.. No leave encashment will be paid.
10. It is mandatory to reside in FRI Campus for which, he/she will be provided a Residential accommodation in the New Forest Campus on the Normal house license fee.
11. In the event of the Medical Officer desiring the earlier termination of the contract, he/she shall have to give atleast two months advance notice to the Director, FRI.
12. Unauthorized absence from the duty without the approval of the controlling Officer shall automatically lead to the termination from the contract .Contract Appointee shall not be entitled for contractual amount for the period of absence from duty.
13. No TA/DA etc. will be paid from this Institute to the candidates for attending the interview and also at the time of joining.
14. The appointment is provisional and is subject to the educational qualification and other certificates being verified.
15. He/She will have to produce all the certificates in original at the time of joining this appointment.
16. No, Government vehicle shall be provided to them.
17. The appointee shall not be entitled to LTC.
18. He/She will be provided medical facility available in NFH for himself /herself only. However He/She will not be entitled for Medical reimbursement from the Institute.
19. The Employees Group Insurance Scheme as well as EPF/GPF will not be applicable to contractual appointee(s).
20. The other terms and conditions of contractual appointment will be governed by relevant rules, order, instructions and various relevant court decisions that may be in force from time to time.
