#### 1. Essential Qualification:

Post Graduate Degree in Science/Forestry or equivalent

Or

Retired Forest Officer not below the rank of Deputy Conservator of Forest

## 2. The Scope of work for Consultant:

Preparation of Working Plan of Chandigarh Forest Division, Department of Forests and Wildlife, Chandigarh Administration. The work will include the following:

- a. Analysis and report writing of the data from the assigned Forest Division.
- b. Preparation of the PWPR and draft Working Plan report of Chandigarh Forest Division as per W.P.C. 2014.
- c. Submission of draft WP report to FRI in specified time.

## 3. Experience:

Applicants must have wide experience of forest management, working of the forests and preparation of working plans.

#### 4. Duration:

The maximum time admissible for accomplishing all the tasks and submission of draft Working Plan is not more than four months from the date of award of Consultancy.
