Tender Notice for Selection of Supplier(s) for Books

Sealed tenders are invited for the selection of supplier(s) for purchase of books. The details of terms and conditions are available in the tender document which can be obtained from the office of the Chief Librarian, National Forest Library and Information Centre, Forest Research Institute (ICFRE), P.O. New Forest, Dehradun–248006 on a cash payment of Rs.590/- (inclusive of 18% GST) or downloaded from the website: <http://fri.icfre.gov.in>. The tenderers should enclose a demand draft for Rs.590/- issued in favour of the Director, FRI, as cost of tender document or the cash receipt issued. The tenders for financial year 2021-22 & 2022-23 should reach to this office on or before 25th March 2021 up to 14.30 hrs which will be opened on same day at 15.00hrs in presence of the representatives of tenderers, if any.

The National Forest Library and Information Centre, Forest Research Institute, Dehradun is planning to select reputed supplier(s) for the purchase of books during the financial year 2021-22 and 2022-23 on the terms and conditions mentioned below.

Terms and Conditions

1. The ordered books will have to be supplied within 45 days of placement of the purchase orders.
2. All the ordered books will have to be supplied. In case the books are out of print, a proof for the same will have to be submitted; failing which the selected firm will be liable to be black listed.
3. In case of books published outside India and whose price are given in foreign currency, the bank conversion rate prevailing on the date of raising of bill, will be considered for making the payment. A proof to this effect will have to be submitted by the supplier.
4. The supply will accompany a price proof in the form of a copy of the publishers/importers/distributors invoices or publishers' catalogue of the supplied books.
5. The supplier will supply the latest edition of the ordered books, unless specified clearly in the order, and not the remainder titles/
6. The supplied books will be verified and the payments will be released only if the ordered books are as per specification and found to be non-defective.
7. The supplier will submit an income tax permanent account no. (PAN/TAN) and GST if applicable.
8. The bidders should submit the details of the authorized distributors or reputed foreign and Indian publishers (supporting documents to be enclosed), etc. to whom they represent along with the discount they plan to offer on the published price of books in a proforma annexed as Annexure -3.
9. Only bidders having annual turnover not less than two crore in each of the last three years will be eligible. The bidders should submit authenticated documentary proof in support of their claim.
10. The tender should accompany the earnest money deposit in the form of demand draft for Rs.25,000/- issued in favour of the Director, Forest Research Institute, Dehradun which will be retained if the offer is accepted by the Forest Research Institute, Dehradun as security deposit and will be returned upon satisfactory completion of the supply/purchase order by the supplier(s), failing which the earnest money will be forfeited. The earnest money deposit of the unaccepted bids would be returned.
11. The Director, Forest Research Institute, Dehradun reserves the right to accept or reject any of the tenders without assigning any reason.
12. Disputes, if any, would be subject to jurisdiction of Dehradun courts.
13. Based on the performance of the selected supplier(s) during the year 2021-22 & 2022-23 this contract may be extended for one more year.
