Note: Following the pre-bid meeting few changes have been made in sub-head 3.1, part of sub-head 2.3 (b), and part of sub-head 3.2.1 of the tender document. The changes/additions are stated below in blue ink.

3.1 TECHNICAL SPECIFICATIONS OF DESIGNING AND PRINTING JOB

(Please refer to Page 16 of 25)

The Designing and Printing of '**Detailed Project Report (DPR) on Rejuvenation of Yamuna River through Forestry Interventions**' shall meet the following specifications:-

- 1) **Layout and design:** In consultation with and to the satisfaction of the Buyer
- 2) **Size:** 11 inches (h) x 8.25 inches (w)
- 3) **Cover with** Multi-coloured printing alongwith UV coating, **lamination** and double embossing; **inside pages** multi-coloured printing with 2 special colours
- 4) **Printing Quality:** High quality CTP (**computer to plate**), alcohol-based offset printing, both side printing
- 5) **Quantity and Pages:** As per details below (including 4 cover pages) (subject to change)

6) **Paper:** Specifications of the paper are as under:

- (i) **For main Volume I and Volume II** – Cover: 300 GSM Art Card Matt Finish. Inside pages: 100 GSM Matt Finish. (Paper sample to be attached by bidder)
- (ii) **For Overview**– Cover: 260 GSM **sheet with die cutting and both sides 7.75” folded**, Iris/Rendezvous fine paper, Inside pages: **130** GSM Iris/Rendezvous fine paper

- 7) **Designing:** Computerized designing by skilled graphic designers alongwith colour correction and enhancement of photographs with conversion to high resolution to the satisfaction of the buyer
- 8) **Printing:** CPC with CTP (**computer to plate**) printing, alcohol based alongwith aqua coating on all pages with two special colours on all pages
- 9) **Finish: Cover page:** Gloss/ Matt and **inside pages:** Matt finish
- 10) **Lamination:** Thermal lamination on cover gloss/matt + UV coating on cover pictures
- 11) **Binding :** Soft bound, with sewing and perfect binding using good quality glue
- 12) **Proofs:** Three colour dummies of each volume are required before the final printing and two dummies in black & white are required while compiling the books.
- 13) **Copyright:** The copyright shall be with the FRI, Dehradun.

2.3. Bid Submission and Evaluation

(b). Financial Proposal (please refer Page 13 of 25 of tender document)

Financial bids of firms that qualify on the basis of technical bid, will be opened and evaluated.

The lowest financial proposals (FM) (in Indian Rupees) will be given a financial score (Sf) of 100 points. The financial scores of other proposals will be computed as follows: $Sf = 100 \times FM / F$ (where F is amount of financial proposal, FM is the cost of lowest financial bid proposal).

Final Evaluation of the Bid

Proposals will finally be ranked according to their combined technical (St) and financial (Sf) scores using the weights $S = St \times T\% + Sf \times F\%$

The weight (T %) given to the Technical Proposal is 70%. The weight (F %) given to the Financial Proposal is 30%.

Other information under sub-head 2.3 (Bid Submission and Evaluation) remains unchanged.

3.2 SPECIAL TERMS & CONDITIONS (Please refer to Page 17 of 25)

3.2.1. Deliverables

- a. The entire order will have to be executed by the Service Provider within **50 (fifty)** days of issue of order from the Buyer (FRI). Time is the essence of the contract and therefore it is mandatory for the Bidder who responds to this bid, to meet these expectations as these are tightly linked to FRI's plans of completing the work within the time frame.
