CORRIGENDUM

Please refer to Tender ID: 2023_ICFRE_697106_1, dated 02.02.2023 published in CPP Portal (<https://www.eprocure.gov.in/epublish/app>) for Security & Surveillance Services for the Recruitment of Scientist- 'B' in ICFRE. After Pre-bid conference, following changes are being made:-

1. In Pre qualification criteria point no. 1 of Section 6 i.e. Qualification/Eligibility Criteria in page no. 8 of tender document i.e. "The bidder shall be a firm/ Pvt. Ltd./ Ltd. Company proprietorship firm registered under the Indian Companies Act 1956 or any other statutory Act of GOI and should be into existence in India for last 5 years as on day of bidding. Partnership firms are not allowed" may please be read as **"The bidder shall be a firm/ Pvt. Ltd./ Ltd. Company registered under the Indian Companies Act 1956 or any other statutory Act of GOI and should be into existence in India for last 5 years as on day of bidding. Partnership firms are not allowed."**

2. In Point no. 5,6,7,8 of Supporting compliance document of Section 6 i.e. Qualification/Eligibility Criteria in page no. 8 of tender document i.e. "Copies of Work Order and satisfactory work performance certificate need to be enclosed may please be read as **Copies of Work Order and satisfactory work performance certificate/self-declaration certificate regarding satisfactory work done need to be enclosed.**

3. In Pre qualification criteria point no. 10 of Section 6 i.e. Qualification/Eligibility Criteria in page no. 9 of tender document i.e. To make the examination process transparent, the bidder would not be allowed to engage themselves for Exam conduction activities with FRI Dehradun through their own-self or any of their consortium partner during the validity of this contract. Any agency/firm/Bidder should not be enrolled with FRI for exam conduction activities currently. This would be limited to offline exam conduction only, except services as part of SOW asked in this tender **may please be read as "To make the examination process transparent, the bidder would not be allowed to engage themselves for Exam conduction activities with ICFRE Dehradun through their own-self or any of their consortium partner during the validity of this contract. The firm who has been engaged for exam conduction activities with ICFRE Dehradun, current ongoing Scientist-B recruitment process would not be eligible to participate in the bid."**

4. It is clarified that Exemption on submission of Tender Fee/EMD will be given against valid MSME/NSIC/KVIC/Recognition certificate from Department for Promotion of Industry & Internal Trade [DPIIT] under valid category and within the validating period of the certificate. Bidder claiming exemption of EMD are required to submit the "bid securing declaration" as per point 11 of page no. 12 of tender document.

All the bidders are hereby directed to submit the bids as per the above revised terms and conditions. The other terms and conditions will remain unchanged except the above. Full details of tender document are also available on <http://fri.icfre.gov.in/tender/>.
