## Chapter- 4: Scope of Work and Condition of Contract

The Forest Research Institute (FRI) Dehradun is premier Institute of Forest Research & Education under ICFRE in the country, having a glorious tradition of serving the country over the last 100 years. FRI, Dehradun has a 28 bed hospital namely **NEW FOREST HOSPITAL**, having good infrastructure facilities. Considering the enormous need of medicines in the New Forest Hospital, the Institute makes all efforts to procure various medicines through bulk purchase from reputed firms/companies on the basis of **Rate Contract (RC)** for a year or so as per the requirement/demand.

The Institute therefore invites competitive prices under **RATE CONTRACT** from the reputed pharmaceutical firms/companies through **e-Procurement** mode for the year **2025-26**. Further the New Forest Hospital is a social serving organization that provides medical facilities to the student of Deemed University, probationers of IGNFA & SFSC, Employees and their families, Retired Employees and their families of ICFRE, FRI, IGNFA, SFSC and FRI Deemed University free of cost. **Therefore, we would like you to provide the medicines at the maximum discounted hospital rates.**

In the process of rate contract, there will be two bid system viz; Technical Bid and Financial Bid. After evaluation of Technical Bid, only the successful bidders who qualify in the technical bid will be entertained for financial evaluation. During the financial evaluation, the rate contract (RC) will be made with the bidders who bid the lowest prices (L1) for the medicines. Therefore, there will be more than one successful bidder/firm as per the quoted lowest prices of the medicines.

**Tender shall be subject to following Terms & conditions:**

### TERMS & CONDITIONS FOR BIDDER

1. Only manufacturing / Marketing Company (s) or authorized supplier or firm authorized by manufacturing/ Marketing Company (s) to participate in this particular tender can participate in this tender. Authorization letter to supplier/ firm for this particular tender shall not be older than one month.
2. E-tender document shall be first downloaded from FRI Website: <http://fri.icfre.gov.in/tender/> and website **GeM-CPP site: <https://eprocure.gov.in/eprocure/app>**, as per above schedule and then tender document and related relevant documents attached as per Check list(Technical Bid) shall be duly filled in & signed and then properly scanned and finally uploaded by the bidder e-tendering procedure given in e-tender notice/document.
3. E-tender should be uploaded on the basis of two bid system, "Technical Bid" and "Financial Bid" in their respective format separately.
4. 5. **The bidder shall ensure that the Technical Bid documents as per Check List of Chapter-2 and Chapter-3 is mandatory to submitted physically (hard copy) on or before 25.02.2025 at 12:30 pm**
6. The e-tender document should be signed only by a person to whom the power is delegated by the competent authority and who is authorized in the name and on behalf of company/firm to do so and become a party.
7. In case, the date of opening of e-tender is declared a public holiday, the e-tender shall be opened on the next working day at the same time.

9. GST shall be payable as per Govt. rules shall be issued by the department on written request of the manufacturer or their authorized supplier if applicable.
10. Conditional offer shall not be entertained.

11. The Bidder and supplier must hold valid licenses as on the date of Bid opening in specified forms for various categories of allopathic medicines issued by the Drug Control Authority of the state under the provisions of Drugs and Cosmetics Act, 1940.
12. The Bidder and supplier must not have been convicted by the State Drugs authorities and no case should be pending under the Drugs and Cosmetics Act and Rules made there under.
13. GST Registration certificate should be available with the Bidder and supplier. Bidder and supplier shall also submit a certificate on the organization letter head stating that up-to-date returns have been filed there are no dues with the concerned department.
14. Financial bid of only Generic/branded Generic medicines GMP certified medicines manufactured and marketed by company with validity up to **March 31, 2026**.
15. **Financial Bid should have as per BOQ & accordance in serial as per chapter -7 of tender document** and should mentioned MRP, Hospital supply rates applicable to this Institute and the other taxes/GST% as applicable (this should clearly indicate the nature and the amount of the tax/GST % in terms of percentage).
16. Every medicine has its own shelf-life period mentioned on the label of medicine. The shelf life of medicines supplied should not have passed more than half of its shelf life at the time of supply.
17. The list of product as per format 3.1 should include contents/ingredients of the product is mandatory to submits physically and online with Technical Bid.
18. The audited financial statement/Turnover certificate of manufacturing/marketing company for each preceding two financial year (2022-23 & 2023-24) must be submitted by the bidder. Annual turn over of the manufacturing/marketing company of the products for each preceding two financial year (2022-23 & 2023-24) must have Rs. Fifty crore (50,00,00,000/-)
19. If bidder have an authorized supplier, through which he will make the supply of medicines to NFH, for this certificate of an authorization must be submitted by the bidder.
20. The rate must be quoted both in figures and words and over writing should be avoided however all cutting/corrections must be dully authenticated, in case of any difference between the rates quoted in figures and words, the rates quoted in words shall be considered to be correct.
21. The rates quoted should include transportation cost up to NFH, FRI, Dehradun clearly mentioning the percentage/rate of GST inclusive and rates should be valid up to **March 31, 2026**.
22. After the rates quoted by the bidder are accepted and the contract is executed, Order/orders shall be placed under this contract to the bidder/ their authorized supplier if any.
23. The bidder will assure that the supply is carried out without a break for the entire period of the contract.
